Subject: <u>Election of Undergraduate and Postgraduate Boards of Studies</u> for the term 1.4.2019 to 31.3.2021.

Dear Sir/Madam,

In accordance with the provisions of Regulation 1.1, Chapter II(A)(vi) at page 52 of the Panjab University Calendar, Volume-I, 2007, there shall be two separate Boards of Studies: one for the Undergraduate courses and the other for the Postgraduate courses. The subjects for which the two Boards are to be constituted are listed as under:

English, Hindi, Punjabi, Sanskrit, Economics, History, Political Science & Civics, Philosophy, Psychology, Public Administration, Sociology, Bio-Chemistry, Botany, Chemistry, Mathematics, Microbiology, Zoology, Physics, Statistics, Geography, Commerce, Police Administration, Biochemistry, Biotechnology, Bioinformatics, Microbiology, Fashion Design, Fine Arts, Computer Science and Application, Defence & Strategic Studies, Home Science, Law, Library Science, Music (Vocal and Instrumental) and Dance, Physical Education and Agriculture.

The Boards for Undergraduate courses will deal with all examinations up to B.A./B.Sc./B.Com. (General & Honours) and the Boards for Postgraduate courses will deal with all the M.A./M.Sc./M.Com./ other Master's level courses/examinations including Postgraduate Diploma Courses of one year duration excluding M.Phil. and Honours School courses at the University Teaching Departments.

The election to these Boards shall be held in accordance with the provisions of the relevant Regulations which are being quoted hereunder:

1.3 The Boards in the above subjects shall be elected every alternate year in the month of March and shall assume office from the first of April following.

A person shall not be eligible to become a member/seek election, if whether by himself or by and person or a body of persons in trust for him or for his benefit or on his account, he has any share

- (a) a firm engaged in printing, publishing or selling books to or for the use of the University or students of any of its courses;
- (b) a contract for supply of goods to the University;
- (c) execution of any works of the University.
- (ii) A person, who in one way or the other, is involved in publication of cheap notes, guides or help books, shall not be eligible to be a member of a Board of Studies.
- (iii) A person shall not be eligible to seek election to a Board of Studies-
  - (a) if he is shown as author, co-author or collaborator of a book prescribed for a university examination excepting M.A. course, whether or not he has in fact contributed to the writing of the book; or
  - (b) if he is found after proper enquiry to be the writer of such book, though his name does not appear as in author, co-author or collaborator.

This shall not apply to a person who prepared a book at the instance of the University and did not receive and royalty for the same.

Persons affected by these provisions shall be given a chance to defend their cases before final action is taken by the University.

- (iv) No one shall be eligible to seek election to more than two Boards of Studies.
- (v) No one shall propose his own name for election to a Board of Studies.
- (vi) A member shall not continue to hold office if he incurs any of the disqualifications mentioned in (i), (ii) and (iii) above.

2.10. A teacher as described in Regulation 2.1(iv) and 2.2(iv) may be proposed by a member of the electing Faculty, as a candidate for election to the Boards of Studies in the subject taught by him together with a statement of his qualification. It shall not be necessary to have these proposals seconded, but it shall be necessary to append the consent in writing of the person proposed.

- 2.12 If the names proposed do not exceed the maximum number of members of the Boards then no election shall be held and the proposed candidates shall be declared by the Registrar to be duly elected as members of the Boards of Studies concerned.
- 2.13. The Faculty shall have the authority to accept the withdrawal of a candidate on the floor of the House.

There would be no election to Postgraduate Boards of Studies in the following subjects as the number of Colleges affiliated for M.A./M.Sc. in these subjects is not more than two:

- 4. Biochemistry
- 5. Microbiology
- 6. Fashion Design
- 7. Computer Science & Applications

Boards of Postgraduate Studies in the following subjects would be elected in accordance with Regulation 2.2(iv) at page 53 of the Calendar, Volume I, 2007:

- 6. Economics
- 7. Fine Arts
- 8. Hindi
- 9. History
- 10. Home Science

- 17. Music (Vocal)
- 18. Physics
- 19. Zoology

The sitting members are not automatically eligible for re-election. Their names have to be proposed if they want to seek re-election, and they must be eligible under the Regulations, in force.

If you desire to propose any person for election to any Board in the Faculty or Faculties of which you are a member, you may kindly fill in and complete the enclosed form and send it to Professor Karamjeet Singh, Registrar-cum-Returning Officer, Panjab University, Chandigarh-160 014, by name, under a registered cover, or deliver it personally in his office during office hours only so as to reach him by 4.00 p.m. on or before Tuesday, 5<sup>th</sup> March 2019.

A separate proposal form is to be filled in and completed for each Board of Studies. If more forms are required, these may be got xeroxed at your end.

The scrutiny of nomination papers would be done on Friday, 8<sup>th</sup> March 2019 at 10.00 a.m. in the office of the Registrar-cum-Returning Officer, Panjab University, Chandigarh. The list of persons, whose nominations are found to be valid, would be pasted on the University Notice Board on the same day, i.e., 8<sup>th</sup> March 2019, itself.

A candidate can withdraw his name by making a written request to the Returning Officer & Registrar so as to reach him latest by **Wednesday**, **20**<sup>th</sup> **March 2019**, **4.00** p.m.

The Faculties will meet at <u>Chandigarh on Saturday</u>, 30<sup>th</sup> March, Sunday 31<sup>st</sup> March and Monday, 1<sup>st</sup> April 2019 at 9.00 a.m. respectively to elect the respective of Boards of Studies in the various subjects. The election will be held by the <u>System of Single Transferable Vote</u>. A list containing the names and qualifications of the candidates seeking election will be supplied in the meeting of the Faculty concerned.
