

The Research score for research papers would be augmented as follows:

Peer-Reviewed or UGC-listed Journals (Impact factor to be determined as per Thomson Reuters list) :

- Paper in refereed journals without impact factor - 5 Points
- Paper with impact factor less than 1 - 10 Points
- Paper with impact factor between 1 and 2 - 15 Points
- Paper with impact factor between 2 and 5 - 20 Points
- Paper with impact factor between 5 and 10 - 25 Points
- Paper with impact factor >10 - 30 Points

(a) **Two authors:** 70% of total value of publication for each author.

(b) **More than two authors:** 70% of total value of publication for each of the Principal/Corresponding Author/ Supervisor and 30% of the total value of publication for each of the joint Authors.

(c) **Joint Projects:** Principal Investigator and Co-investigator would get 50% each.

(d) For joint authors of books/joint editorship/joint development of MOOC's or e-content, if there are two contributors, each shall get 70% of the score and if there are more than two contributors, then each should get 50% of the score (this would discourage the addition of redundant names).

Note:

- Paper presented if part of edited book or proceeding then it can be claimed only once.
- For joint supervision of research students: the formula shall be 70% of the total score for all Supervisors.
- * For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). (Policy Document) and 6. (Invited lectures/Resource Person/Paper presentation) shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.
