A copy of the Circular dated 10.06.2014 is enclosed herewith. The specifically Para III of the Circular No. 5303-5404/Estt.-I dated 10.06.2014 is reproduced below:-
 - *III. At the end of the Academic Session, a report regarding the work and conduct of the Guest Faculty will be given by the Chairperson to the Academic and Administrative Committee of the Department.

If the work and conduct of the Guest Faculty is found to be satisfactory then the Academic and Administrative Committee may recommend his/her name as Guest Faculty to teach in the Department for the next Academic Session w.e.f. the date the next Academic Session starts. However, in case, the work and conduct of the existing Guest Faculty in the Department is not found satisfactory during the Academic Session, then the Chairperson/ Head of the Department on the recommendations of the Academic & Administrative Committee of the Department may relieve him/her after issuing the show cause notice.

Keeping in view the above referred circular, the Chairpersons of the Department are requested to kindly follow the circular in letter and spirit while recommending the case of Guest Faculty for extension of each semester.

- Further, it is again requested that the proposal for current semester/ session regarding Guest Faculty, duly recommended by the Academic and Administrative Committee of the Department be submitted as per Annexure-I and II already circulated vide No. 877-976/Estt.-I dated 06.07.2010 (Copy enclosed).
- 3. In addition to above, the circulars with regard to appointment of Guest Faculty may also be followed in letter and spirit.

CIRCULAR

In pursuance of orders passed by the Hon'ble Punjab & Haryana High Court in CWP No. 13388 of 2012, the Syndicate at its meeting held on 26.4.2014 (para 17) has decided that the recommendations of the Committee dated 11.2.2014 regarding policy norms of appointment of Guest Faculty in the University Teaching Department be modified and approved, as under:-

- A notice for inviting applications from the prospective candidates for appointment as guest faculty be put up on the notice board of the department as well as on the Panjab University website.
- The appointment of Guest Faculty be made through the Selection 11. Committee, consisting of the following.
 - .. Chairperson a) Chairperson of the Department
 - b) One nominee of the Vice-Chancellor
 - c) Two to three subject experts from the department or the concerned/allied subjects within the same Faculty.

The names of the subject experts will be sent by the Chairperson to the Vice-Chancellor for approval on the recommendation of the Academic and Administrative Committee of the concerned department. However, the Vice-Chancellor can add or delete any name in the recommended list of subject experts.

At the end of the Academic session, a report regarding the work III. and conduct of the Guest Faculty will be given by the Chairperson to the Academic and Administrative Committee of the Department.

If the work and conduct of the Guest Faculty is found to be satisfactory then the Academic and Administrative Committee may recommend his/her name as Guest Faculty to teach in the department for the next academic session, w.e.f the date the next Academic Session starts. However, in case the work & conduct of the existing guest faculty in the department is not found satisfactory during the academic session, then the Chairperson or Head of the Department on the recommendations of the Academic and Administrative Committee of the Department may relieve him/her after issuing the show cause notice.

The Guest Faculty may also be appointed from within the IV. permanent/regular University/College teachers for the academic on the recommendation of the Academic Administrative Committee of the Department, but these teachers have to submit the NOC from the Head of the Department.

The Chairpersons/Heads of the Departments/Centres/Institutes of the University may submit their proposal/s for appointment of Guest Faculty accordingly, from time to time as and when it is required alongwith complete information/documents as per circulars already issued vide No. 409-508/Estt.I dated 10.3,2010, No. 877-976/Estt.-I dated 6.7.2010 and No. EST/14/-1948-2048 dated 6.3.2014 enabling to get the approval of the competent authority.

It is requested to act accordingly.
